### TRANSFER ORPHANAGE TO PEORIA BUILDING

Orphans and Sisters Leave Metamora Tuesday. St. Mary's orphanage in operation since its establishment in 1877 was transferred to Peoria. Furniture was shipped by railroad and a dozen cars owned by citizens of Peoria transferred the 55 children and 10 sisters to their new home. Bad train service and the inability to get sufficient water were assigned as reasons for the removal. The old building and grounds are worth \$50,000 and there is a farm of 200 acres adjoining it.

### From the July 26, 1904 Metamora Herald

Among the enterprising citizens of the town is John D. Zimmerman, the saloon merchant of this city. He is a native of Germany but has been a resident here for the past thirty-seven years.

"Uncle John" as he is familiarly known, has made a good citizen since he has been here, and all have grown to like him. For a number of years he was a farmer residing in Partridge Township and today has one of the finest farms in that township. Three years ago he came to Metamora and entered the saloon business and made a success from the very beginning.

Footnote: Uncle John died in December, 1927 and is buried in St. Mary's Cemetery.

**Landscaping Project Moves Forward**

Following Sue's presentation, the board approved her plan, which will add different perennials from year to year and be supplemented each year with annuals in order to maintain color throughout the summer months. It also includes a picket fence, which is now being added.

A herb garden is on the schedule for next summer, which can also serve as a fund raiser, as well as an education resource. Eventually the project will be turned over to local Master Gardeners.

**From the February 15, 1915 Metamora Herald**

Shipments of ice for local dealers began arriving from Lacon the first of the week. The ice houses of C.H. Hindson & Co. and the Metamora Ice Company have been filled. The ice received is about ten inches in thickness and it has been packed under ideal weather conditions. The business of the Metamora Ice Company has been taken over for the coming year by Edward Theena. (See picture)

**From the March 7, 1930 Metamora Herald**

Another old relic is gone. Ice houses are as obsolete as livery stables and private barns and like the latter are being removed from the landscape. One of the remaining ice storage houses that in halcyon days of yore furnished frigidty for a frothing brew that froths no more over public bars, went the way of all things material yesterday. George Sluga, who juggled many a schooner made cool by ice from this old building, was master of ceremonies and Herman Rohman, his assistant, in removing the old ice house on the old-time J.B. Knoblauch property.


Since both beer and ice have faded out of the picture the only purpose served by the old building was surface upon which to display circus advertising wand, as such, citizens generally were not keen about its scenic qualities. F.W. Wagner, present owner, therefore ordered its removal. Messrs. Sluga and Rohman made such short work of the task that there was little time for anyone to shed tears.

(Editor's note: the old ice house stood in the lot between the florist shop and the phone company.)
